SUMMARY

Offer Price and Net Proceeds

- The Offer Price has been determined at HK\$0.47 per Offer Share (exclusive of 1% brokerage fee, SFC transaction levy of 0.0027% and Stock Exchange trading fee of 0.005%).
- Based on the Offer Price of HK\$0.47 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deducting the underwriting fees and commissions and estimated expenses paid and payable by the Company in relation to the Share Offer, are estimated to be approximately HK\$41.3 million. The Company intends to apply such net proceeds in accordance with the purposes set out in the section headed “Statement of business objectives and use of proceeds” in the Prospectus.

Applications under the Public Offer

- A total of 6,049 valid applications were received pursuant to the Public Offer on **WHITE** and **YELLOW** Application Forms and through giving **electronic application instructions** to HKSCC via CCASS for a total of 509,920,000 Public Offer Shares, equivalent to approximately 33.99 times of the total number of 15,000,000 Public Offer Shares initially available for subscription under the Public Offer.
- Due to the very significant over-subscription in the Public Offer, the reallocation procedures as described in the section headed “Structure and conditions of the Share Offer - Re-allocation of the Offer Shares between Placing and Public Offer” in the Prospectus have been applied. As the number of Offer Shares validly applied for in the Public Offer represents more than 15 times but less than 50 times of the number of Offer Shares initially available under the Public Offer, 30,000,000 Shares have been reallocated to the Public Offer from the Placing, so that the total number of Offer Shares allocated to the Public Offer has been increased to 45,000,000 Offer Shares, representing 30% of the total number of Offer Shares initially available under the Share Offer.

Based on the Offer Price of HK\$0.47 per Offer Share, the net proceeds from the Share Offer to be received by the Company, after deducting the underwriting fees and commissions and estimated expenses paid and payable by the Company in relation to the Share Offer, are estimated to be approximately HK\$41.3 million. The Company currently intends to apply such net proceeds as follows:

- approximately HK\$20.3 million, representing approximately 49.3% of the net proceeds to be received by the Company, will be earmarked to take out surety bonds issued by banks or authorised insurers in the amount of certain percentage of the contract sum in favour of the Group's customers for the wet trades projects that the Group plans to tender;
- approximately HK\$8.0 million, representing approximately 19.2% of the net proceeds to be received by the Company, will be used for expansion of the Group's workforce to ensure it has sufficient manpower for its newly awarded wet trades projects and projects for which the Group plans to tender;

Five invalid applications have been identified. No application for more than 100% of the Public Offer Shares initially available under the Public Offer (that is, more than 15,000,000 Public Offer Shares) has been identified.
